Tournament Rules

1. Eligible participants who are not USBC members can qualify, prior to participation, by paying the appropriate association membership dues.
2. Competition in each event will be unlimited. Rule 315b-d will apply for prize winnings. Team Event will consist of three (3) men or three (3) women bowling a 3 game set. Singles event will consist of a 3 game set.
3. Handicap will be 90% of 225.
4. Entering average:
 - Entrants shall use their highest certified average of 21 games or more for 2010-2011 season.
 - Or entrants without such an average may use their highest certified summer league average of 21 games as of August 1, 2011.
 - Or use highest current certified league average of 21 or more games as of time of participation. Entrant must bring verification.
 - Any entrants not meeting one of the above criteria must bowl scratch.
 - If current season's average of at least 21 games at the time of bowling exceeds last season's average by 10 or more pins, current season's average must be used (Rule 319a).
5. USBC Rule 319a(3) will be in effect. **Bowlers are responsible for verifying their own average.**
6. USBC Rule 319d and Rule 319e will not apply. Entrants do not need to submit their previous tournament winnings and the average adjustment rule will not apply.
7. Eligibility: Open to current season members of USBC.
Teams will be composed of 3 men or 3 women.
8. Protests involving eligibility or playing rules must be made to tournament management in writing within the time limits in Rule 329. The decision of tournament management will be final unless a written appeal is filed with USBC Headquarters within the time limits in Rule 329.
9. Entries shall close at 3:30 PM, January 21, 2012, one (1) hour prior to the start of the last squad at 4:30 PM, January 21, 2012.
10. **The prize ratio** will be at least one (1) to five (5) or major fraction thereof for the Team event; the prize ratio will be at least one (1) to eight (8) or major fraction thereof for the Singles event. The prize ratio will be one (1) to fifteen (15) for All Events. Prize money will be returned 100%.
